### DUES - DO WE OR DON'T WE?

This article is intended to clear up confusion about dues during the Covid-19 induced hiatus of club activities.

Our club fiscal year runs from July 1st through June 30 with monthly meetings (no meetings are held from June through August). According to the by-laws, dues are due by September 1, with a "grace" period through December 31. After the grace period ends on December 31, the individual or family membership is considered suspended (i.e., not in good standing). The member/family will be in suspended status through December 31 of the following year. No newsletter will be sent to those in suspended status, their membership card is no longer valid, and they are not permitted to attend classes or use club equipment. Payment of dues during this period will return the member/family to good standing. If dues are not paid by the end of the following December, the member/family is dropped from the club roster and would need to complete a new Application for Membership.

A number of new memberships are received during or shortly after the annual show in March. This year was no exception. Questions inevitably arise when new members pay in March, then receive notice that dues are again due six months later. While it may cause unhappiness and confusion, this policy is according to the By-Laws and cannot be changed without amending the by-laws.

Through the years various boards have struggled with how to handle this situation. This year the Covid pandemic has further complicated things because the club is closed. We have been unable to hold meetings, although access to the shop and classes are available on a limited basis.

Club expenses – utilities, insurance, property tax, etc. – must continue to be paid whether or not the club is open. Class fees cover some, but certainly not all, of the specific expenses incurred by the class. As of 2021, club income will be severely reduced and we will need everyone's dues to help meet the expenses.

The following excerpts from the By-Laws (http://sgams.com/bylaws/Bylaws.htm) serves as a reminder of the policies regarding dues. (Italics are mine.)

Article III: Membership

Section 2: Admission to Membership

Any person who is interested in the purposes and goals of the Society may obtain membership by completing an Application for Membership Form, *volunteering to serve on at least one committee, and paying one (1) year's dues.* Upon acceptance into the Society a membership card shall be issued.

### [Dues, cont.]

Section 6: Members in Good Standing

Members whose annual dues are paid and who have not been suspended shall be considered "members in good standing."

Article IV: Dues and Fees

Section 2: Date Payable

The annual dues shall be payable on September 1.

Section 3: Delinquent

Dues shall be considered delinquent if not received by December 1 and membership shall be suspended. If dues are not received by the next September 1, membership shall be forfeited. [Ex: If a member joins in March at the time of the annual show, or at any time during that year prior to August 31st, dues paid at that time are for the current fiscal year. Dues for the following fiscal year will be due again on September 1. This should be explained to new members no matter when they join.]

Section 4: Fiscal Year

The fiscal year of the Society shall be from July 1 through June 30.

Anyone attending a class at the clubhouse and using club equipment MUST be a member in good standing.

As a short-term fix, I have instructed the Membership Chair to email cards to members with an effective date (the month dues are received) rather than a "through" date.

## Something Fun from the USGS.gov Website:


Bring out your inner geologist and take the Geologist Tongue Twister Audio or Video challenge!

## Gem of the Month: NOVEMBER: CITRINE & TOPAZ

November is also a month with two Gem Stones associated with it, both with yellow, gold and brown hues that evoke the warm colors of Fall and Harvest. The two stones are often mistaken for one another, although they are unrelated.

Citrine is a mineral made up of quartz and derives its name from the citron fruit because

of its lemon-like color, which is caused by traces of iron in the quartz. In the 17th Century, Scottish men used citrine to decorate the handles of their daggers, known as dirks. It was also popular during the Art Deco era. Brazil is the largest supplier of this gem.

Pure Topaz is colorless! Precious topaz ranges from orange-yellow to dark brown. It derives its name from *Topazios*, the ancient Greek name for St. John's Island in the Red Sea, although the yellow stones mined there may not have been Topaz at all, but the name stuck! The most prized is Imperial Topaz a vibrant orange with pink undertones, found in the Ural Mountains of Russia in the 19th Century and named to honor the Czar. The most famous topaz is the Braganza, in the Portuguese Crown jewels.
